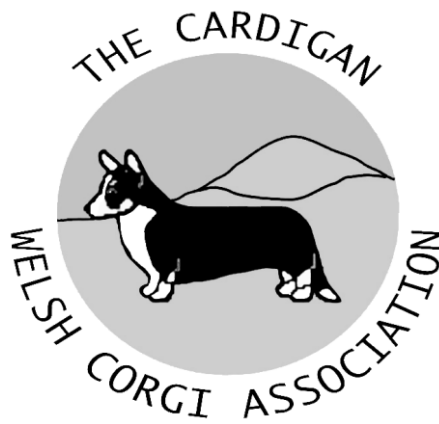
All members of the current committee have indicated their willingness to continue for 2022/2023. However, this does not preclude new nominations being offered which would be voted upon at the AGM

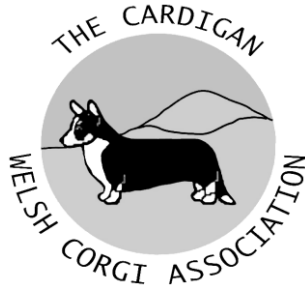

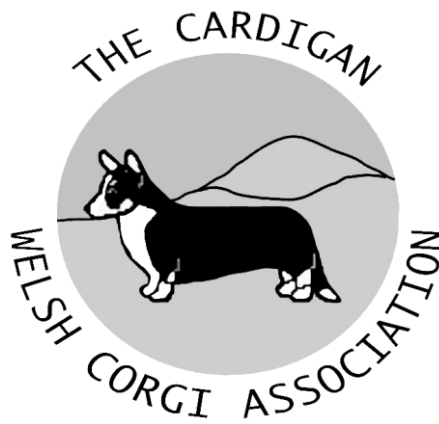
